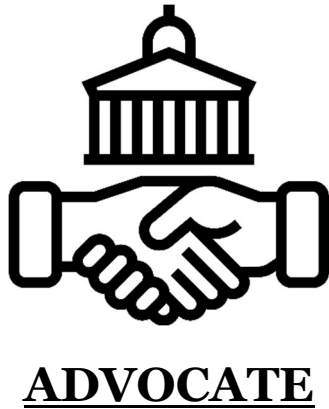
Not able to Donate Blood but Interested in **Helping the Foundation**

Title Industry of Florida PAC

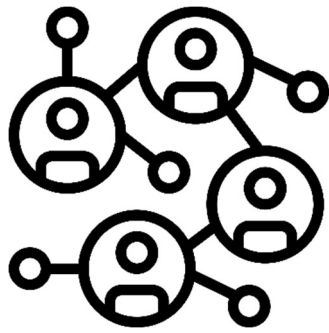

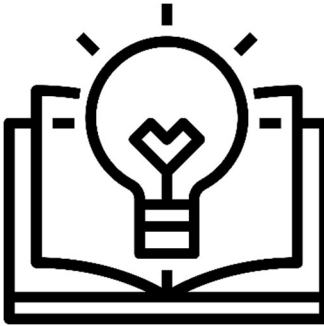

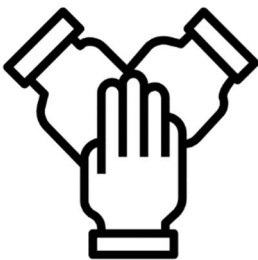
